## **Optimisation of our premises**

- A number of initiatives are on-going
  - Complete Campus Concept (KTH on-going)
  - A new cost model for cost division of our premises (KTH on-going)
  - Optimal use of our premises (KTH on-going)
  - Optimal use of EECS premises (EECS on-going)
  - Digital and attractive workplace (EECS on-going)
  - Tele working possibilities and localisation of our administration (EECS to be started soon)
    - > Project will start end of November with a pilot project regarding tele-working
    - > After the RAE and need analysis has been finalised, (hybrid) localisation of the administrative support will be included in the project
    - > Project will be on-going for approximately 1 year in total (appr. end date December 2022)
  - RPL and TMH laboratory project will continue with small modifications
  - A taskforce regarding Campus Kista will be established soon.



# Reporting accidents, near misses and risks – the new IA reporting system

- Since 1 November, KTH has a digital tool to aid with reporting, investigating, remedying and following up occurrences in the work environment.





# Why is it important to report?

- To take measures we first have to know that something has happened, or that there is a risk that something could happen.
- Something you might think is insignificant could in fact cause big problems later on.
- When employees report more, we are able to see patterns and can focus our efforts within the work environment where it is most needed.
- The reason to report is not to put blame on somebody, but rather to actively contribute to improving the work environment.

#### How reports are followed up

- Each report is followed up by the responsible line manager and the safety representative (skyddsombud).
- All reports are followed up in SSG (Skolans samverkansgrupp).
- If the needed action to be taken is of such character that it needs be addressed higher up in the organisation, this will be done.
- We have already seen an increased willingness to report it's through reporting we can create a learning organisation.
